**Mendieta Garrote, Eva / Molina Martos, Isabel;** Social Revolt in Europe in the Early Modern Era: Women's Participation and Feminine Discourse in the Bilbao Salt Tax Revolt (1631-1634).

**Arbelbide, Xipri;** Ferdinand Elosu, doctor of anarchist ideas (Bordeaux 1871-Bayonne 1941).

Abstract: Fernando Elosu, son of an immigrant from Etxalar in Bayonne, Rosa Antonia Elosua and doctor Ernest Lafont, was born in Bordeaux in 1875. Doctor in 1900 in the Aldudes and later in Baiona. Due to his ideal anarchist and therefore alien to the

Catholic Church, generated in the Baiona of his time some rejection, however he actively participated in associations in favor of human rights, the popular university. He also manifested himself pacifist at a time when others proclaimed the war for the reconquest of Alsace and Lorraine. He was imprisoned for his pacifist and communist ideas and when he was released , 65 years old, after 8 days he died. In the obituaries of the press of Bayonne they extolled his quality as doctor of the por people. His daughter Suzanne, also a doctor, became the first woman elected to the city council of Baiona.

**Kortazar-Billelabeitia, Jon;** Gipuzkoa in 1936: Comparative analysis of the "blue terror" in two locations: Beasain and Mondragon.

Abstract: We will carry out a comparison between the patterns of the repression by francoist army and administration in two towns of the Basque province of Gipuzkoa during mid-1936: Beasain and Arrasate-Mondragon. The both towns were among the first towns in the process of industrialization and they grounded an well organised workers' movement. In both towns an instantaneous and massive massacre was carried out. This article will examine the similarities and differences between both cases and will widen the focus to contribute to the understanding of the repressive measures in Gipuzkoa.
